Park & Rec Committee

The Park & Recreation committee met on Wednesday, March 27, 2023.

Members Present:	Councilors Josh Broadwater and Dave Frank.
Members Absent:	None.
Others Present:	Craig Britton, Brian Burkholder, Dan Funk & Joel Young

Disc Golf Proposal: Resident Eric Jenneke explained that he would like to get a disc golf program started that would get more young people involved with the sport. He has already talked with the community education director and he also talked with Sports Headquarters about providing the funding to provide a starter kit of discs for each participants. Sports Headquarters is interested in providing the discs to the participants but they would need a sign to be placed on the course while the program is in operation, June 12 – 15. The committee is supportive of the program.

Sale of current sprayer and purchase of new sprayer: Burkholder reported that he would like to sell the current sprayer, which doesn't meet the city's needs, and to purchase a new sprayer. He said that Dan Funk has gotten certified to apply chemicals and has done research to find the right kind of spraying equipment. Burkholder estimates that the city will save about \$5,600 a year by spraying ourselves. They reviewed several options and determined that the best option would be the Field Boss Eco Lite at a cost of \$2981.25.

Wide Area Mower: Burkholder reported that it is time to replace the wide area mower and recommended the purchase of a John Deere at a cost of \$32,888 - \$36,000.

Camping Alternatives: Britton showed four potential sites of 25' x 65' lots placed on the current horseshoe area, in Mill Creek Park. Water would be provided from the baseball dugout and electricity would be extended from the lift station. A dump station would be installed along the entrance drive to the park. The water and electric cost would be about \$19,000 and the water would cost about \$7,000. The dump station would be in the range of \$20,000 - \$25,000, including water service to the dump station. The committee recommended to move forward with including the cost and improvements in the street project.

Shady Oak Park / 2023 Street Project: The committee reviewed the potential route for installation of the water line and discussed the size of the cul de sac on Prospect Street. They also considered the construction of a drive that would extend from Prospect to Hawley Street and the installation of some parking spaces in the park, in lieu of constructing a cul de sac. The committee recommended the construction of a more properly sized cul de sac of 35' and avoid the idea of a drive through the park. Bidding for the street project is expected to be published within the next few weeks.

Chatfield Girl Scouts: Little Free Library

OVERVIEW

Chatfield Girl Scout Troop 48032 collectively built and designed a "little free library." They are asking the Park and Recreation subcommittee for consideration on allowing them to install the library on city property.

PURPOSE

Junior and Cadette members of the Troop identified top reasons why they believe a little free library could positively impact the residents of Chatfield. They include the following:

- Encourage reading for not only kids but adults.
- Have a place to look for new books when the library is closed.
- Give residents a place to donate and swap out books they've already read.

In addition, Brownie members of the Troop designed "kindness rocks" meant to be placed in the box on top of the little free library. These rocks have been painted and sealed for outdoor environments. Kindness rocks encourage people to spread fun, cheerful messages throughout the town by placing colorful rocks in gardens, rock beds, etc.

SPECIFICATIONS

The little free library is built out of high-quality wood and secured using a mix of glue and screws. The door has a locking mechanism to keep it closed, a polycarbonate window for passersby to see in and a rubber window seal to keep it dry. Additionally, all joints and the box on the top have been sealed with silicone caulking to protect against the elements. To install the little free library, we plan on utilizing the help of Girl Scout families, many of whom have professional construction experience.

UP-KEEP & YEARLY PLAN

Maintenance and up-keep will be performed on an as-needed basis and quarterly schedule by our Troop Leader and members of our Troop.

Spring-Early Summer




Late Summer-Fall

Thank you for the note. Ironically, I was having thoughts about this last week and intend to talk with Brian Baum more about the proposed plan. We spoke a bit last week. Whitetail Vinyl will do a 3'x4' vinyl welcome sign, 24"x24" course map and 9 hole plaques that will be 9"x12". He will powder coat the material and then laser engrave the course map and the hole plaques.







Action Requested: To consider and approve the donation of 2 polycarbonate backboards and hoops from the Chatfield Youth Basketball Association (CYBA)

Background: We currently have a total of 6 basketball hoops at Mill Creek Park. We will keep the existing hoops on the sides of the court and just replace the 2 at the north and south ends. We will be using the existing gooseneck poles and put a new polycarbonate backboard on those poles with bracing. The hoops will be fixed so they can not be lowered.

The CYBA is willing to put \$5,000 towards the hoops this year. The city will be installing the hoops ourselves.

We recommend purchasing the equipment through Future Pro since they are the cheaper of the 2 bids. Both bids are for the same backboard, hoop, bracing and mounting plate.


